## TODAY'S ASSAULT ON OUR HEALTH

- Attempts to make illegal or available only by prescription the myriad of natural supplements, to which today we *already enjoy uninhibited access*.
- To make illegal or otherwise unavailable many of the natural healing services and technologies we freely enjoy today and which cause us no harm, as well as yet-to-be discovered natural products and services.
- To forbid the public disclosure of breakthroughs in the treatment of illness and the advancement of wellness using natural products and services.
- To deceptively compromise the standards of organically grown food by redefining "organic" to include the use of the very pesticides, hormones, irradiation, additives, animal abuse and genetically modified foods we care to avoid.
- To condemn us to accept only surgery, radiation and pharmaceutical drugs to make us well, healthy and vibrant.

## RON PAUL'S SOLUTIONS AND BELIEFS

 Dr. Ron Paul, M.D., has reintroduced the Health Freedom Protection Act, H.R. 2117, a bill with broad support in the natural health community. "This bill would stop the FDA from censoring truthful claims about the curative, mitigative, or preventative effects of dietary supplements."

- He opposes all forced vaccinations.
- He opposes world government mandates such as the WHO's Codex Alimentarius, which force us to abide by harmful, corporate dictated dietary and health laws.
- He defends our free access to dietary supplements and natural health solutions.





"The FDA, like all federal agencies, ultimately uses its regulatory powers in political ways. Certain industries and companies are rewarded, and others are punished. No regulatory agency is immune from politics, which is why the FDA should not be trusted with power over our intimate health care decisions.

The real issue is not whether supplements really work, or whether FDA drugs really are safe. The real issue is: who decides, the individual or the state? This is the central question in almost every political issue. In free societies, individuals decide what medical treatments or health supplements are appropriate for them."
