Aaron Starr moved to re-appoint Ted Brown, Willard Michlin, Daniel Wiener, Aaron Starr, and M Carling to the Operations Committee (the Chair is an automatic member). The motion passed, with 9 in favor, 3 opposed, and 3 abstaining.

An election was held for the two vacant positions of Executive Committee Alternates. Lois Garcia received 11 votes and will be the First Alternate; John Eckl received 9 votes and will be the Second Alternate; and Frank Manske received 8 votes.

An election was held for the two vacant positions of Libertarian National Committee (LNC) regional representatives. M Carling received 14 votes and Aaron Starr received 10 votes (both were elected); Mark Selzer had 4 votes; and Juanita Ramirez had 2 votes.

An election was held for the two vacant positions of LNC alternates. Richard Burke received 11 votes and will be the First Alternate; Scott Lieberman received 8 votes and will be the Second Alternate; Bruce Cohen had 7 votes; and Mark Selzer had 4 votes.

The preliminary budget for 2006, which had been adopted at the November 19, 2005 Executive Committee meeting, was amended by changing the "Cost of Support and Revenue / Convention" line item from \$500 to \$0. The resulting budget (see attachment) was ratified on a roll-call vote of 14 in favor, 0 against, and 1 abstention:
